IMPORTANT DEFINITIONS

Itinerant Merchant – Any person who shall expose for sale, any goods, wares or articles of merchandise, not being a regular merchant of the town, and shall include any person who exposes his or her goods for sale in a flea market, a parking lot or an unused portion of a building or from any fixed location within the town.

Peddler – Any person engaged in the act of peddling of articles of merchandise.

Peddling — The sale or offering for sale from house to house by any persons from a cart, truck, automobile or other vehicle operated over and upon the streets and highways any articles of merchandise and shall include, without limitation, fresh fruits and vegetables, farm products, household medicines, remedies and other articles.
